In Cyber Watchdog, players will recognize 100 cybersecurity terms, job descriptions and salaries, while vigilantly guarding cyberspace, completing client missions, facing down a global band of hackers, and pushing their skills to the next level!

Here's a brief overview of what students will learn and experience by playing Cyber Watchdog:

Avatar creation:

It's important for students to not only explore careers but actually see themselves in those different industries and roles. Players can customize their character to look how they want, selecting from a wide variety of skin tones, hair colors, hairstyles, outfits, and accessories.



Storytelling:

Students will star in their own cyber story, empowered by Cyber Watchdog's narrative interstitials. These interactive cutscenes take the player from a newly hired Watchdog to an expert in the force who takes down a nefarious group of hackers!




CERBERUS HEADQUARTERS: levels 1-1 to 1-8

Minigame challenges:




PASSWORD HASH - learn about weak passwords, salting, and hashing

PC BUILDER - identify computer hardware to construct a PC





Concepts covered in core gameplay:



RAISE THE DEFENSE! - construct strong passwords and learn about cyber protection to build proactive defenses for your machines.



CYBER WATCHDOG BADGES:

Players can earn six badges in Cyber Watchdog. Each badge corresponds to a different grouping of cyber curriculum and thus reflects a certain amount of exposure to the material. The player's proficiency is measured by game progress, minigame success, and in-game decision making.



CYBER STARTER - The player has learned the basics of cybersecurity, computer building, and cryptography.



CYBER CITIZEN - The player has seen how cybersecurity protects the world by defending critical infrastructure.



CYBER STAFF - The player has been exposed to end user education, networks, and good cyber practices.



CYBER SLEUTH - The player has learned about cybersecurity's relationship to money and digital investigation.



SOFT SKILLS - The player has demonstrated good communication practices, work ethic, professionalism, and critical thinking skills throughout the game.



CYBER SKILLIONAIRE - The player has guarded cyberspace against intruders and has proven their worth by earning 75% of stars in the game and all other badges.
